Inventory Fee:

Relet Fee:

A fee of £180 including VAT will apply when a property is relet to include the registration of the deposit to the TDS.

Submission of non-resident landlords receipts to HMRC – £60.00 (inc VAT) quarterly

To remit and balance the financial return to HMRC quarterly – and respond to any specific query relating to the return from the landlord or HMRC

Arrangement Fee for works over £1000.00 - 12% of net cost

- Remit any disputed amount to Scheme for final adjudication
- Unprotect security deposit
- Instruct contractors; obtain quotes; organise repairs / replacement/cost of any broken or missing items in accordance with TDS T&Cs.
